Hello,

Based upon current population growth trends in our county and continued need for capacity building of child care slots in all regions of the county, the following zip code priority updates are requested by RCOE prior to the report moving forward for approval and submission:

92582 San Jacinto, change from Priority 3 to Priority 1 - according to US Child Care Deserts, this is a high poverty area with a scarce child care supply

92585 Romoland/Menifee, change from Priority 3 to Priority 1 - this area is one of the highest growth areas in our county with a 6.7% population growth rate between the 2020 census and 2022; the anticipated city population is estimated to be 126,000 by the end of 2024 which is over 22,000 new individuals moving into this zip code between 2020 and 2024; this is a high population area with scarce child care supply, and both the Menifee and Perris districts have opened new elementary schools in their districts in response to the population growth

92548 Homeland, change from Priority 3 to Priority 1 - this rural community has high poverty and is identified as a child care desert in our county - with the growth of Romoland, areas of Homeland may be accessing the infrastructure and supports in Romoland with the absence of their own and Romoland is lacking adequate supports for their own community

92240-92241 Desert Hot Springs, change from Priority 3 to Priority 1 - this is an exceptionally high need community is the fastest growing area in the Coachella Valley with an estimated 25.3% population growth (median age 34.9 and below state median income level as the average salary) based upon information provided and attributed to the Census in an article published by the Desert Sun
